## Cargill's Pacer contract April 1 - June 30 achieved a higher price than the harvest average 9 out of 10 years.

If you committed bushels to the Cargill Pacer and applied the suggested time period of April 1 - June 30 for Corn, you would have exceeded the harvest average by $\mathbf{\sim 3 8 . 4}$ cents per bushel over 10 years and you would have also exceeded the January thru October Average by $\sim 18$ cents per bushel.
