*** DISCOUNTS WILL BE FIGURED ON DRY BUSHELS ***

We will shrink wet bushels by a factor of 1.4% for each 1% moisture over 15.0%.

Dry bushels will be applied to contracts. In calculating shrink, we will use .70

(2 X .70 = 1.4%) for each 1/2% of discountable moisture content.

Buyer reserves right to reject or discount musty, heating, sour, hot corn, or corn with a commercially foreign odor. Buyer also reserves the right to reject corn with live insect infestation and corn with weevils dead or alive. Stones, aflatoxin, vomitoxin, sample grade corn or distinctly low quality are also subject to rejection. Corn not grading within above limits will be subject to negotiation between buyer and seller.
